## **Cold Water Tank Jacket**

### Use:

Mayplas Cold Water Tank Jackets are designed for the thermal insulation of domestic cold-water storage tanks to help prevent freezing during cold months.

### **Construction:**

The jacket and lid is manufactured from a resilient low density mineral wool produced as either 60mm or 80mm section enclosed in black polythene for ease of installation.

The insulant is produced in accordance with EN 13162 (factory made mineral wool) and defined as Euro class A1 reaction to fire according to EN 13501-1.

The enclosing material is heat stable 100  $\mu$ m black polythene with self-extinguishing properties. Each jacket is supplied with tying ribbons.

An optional Rigid lid is available manufactured from Expanded Polystyrene.
